DMAX machines the engine block, cylinder head, and crankshaft in the 670,000 sq. ft manufacturing facility in Moraine. These components, along with purchased parts, are assembled into the 6.6L Duramax Diesel engine which is fully tested in a dynamometer type test cell prior to shipment to the assembly plant customer.
